CMH remained open during the height of the COVID-19 pandemic and continued to serve the individuals and families enrolled in our services. The agency pivoted to a blend of virtual and in person services that used creative strategies to meet the needs of persons served. The agency was reviewed

by CARF (Commission on Accreditation of Rehabilitation Facilities) and achieved Three Year Accreditation — the highest level available. CARF accreditation signals a provider's commitment to continually improving services, encouraging feedback, and serving the community. The agency Quality Department takes the lead ensuring the agency is compliant with CARF Standards and is prepared for the triennial site reviews. The agency added capacity in our Quality Department promoting Michelle Practice with over 27 years working in human services. She has worked at Lapeer County Community Mental Health for over 10 years in Quality Improvement. Lisa has five years' experience in health education

While we focused on revamping and reorganizing things at Lapeer CMH over the past year, we also continued to focus on providing stigma-free mental health care to ensure the overall health and wellness of the people we serve.

Gould-Rice, LMSW to the new position of Quality Management Supervisor and backfilling the Quality Coordinator position with Lisa Ruddy, BS. ◀o better serve as the county's leader in mental wellness, the Lapeer County Community Mental Health (CMH) team is proud to reveal their newlycreated brand to the community.

The new brand includes the updated tagline, "Support and care for complete wellness," which builds on the increasing need to see mental health as part of one's overall health and wellness and remove the stigma sometimes attached to seeking help for one's mental health.

Along with a new tagline, the updated brand includes an updated mission, vision, brand promise, elevator speech, and logo. CMH has launched its newly designed website at www.lapeercmh.org.

Tust who exactly is Jerry Webb? What we can tell you is that he's a father of three children and is no stranger to serving his community. He's lived in the area for three decades now and has been an insurance agent for American Automobile Association (AAA) since 1990. He's also served on several boards, like the Lapeer County Habitat for Humanity, Kiwanis Club of Lapeer, United Way and Foster Care Review Board.

More importantly, Webb is now CMH's newest board member and is dedicated to making sure CMH clients get connected with the best clubhouse member Janet Pratt, programs depending

on their needs. While Webb may be new to the CMH board, he's had ties to Harmony Hall for a while now. Harmony Hall is a CMH satellite program dedicated to supporting people with serious mental illness and offering

them skill building opportunities. Some of those opportunities include helping club members learn how to handle money or food, or learning how to edit videos, create social media content or learn how to use a computer. Then club house staff help employees that I've ever had," said members use those skills to help find them a job within the community.

He first learned about Harmony Hall and the services they provide during a Kiwanis Club meeting in 2014, and he was interested in

helping club members get placed in jobs throughout the community.

That was also around the time that he identified the need for a receptionist in his office and when he had met a Harmony Hall club member who needed some help finding an affordable insurance policy. Word quickly spread throughout the clubhouse about how helpful and kind Webb was.

"I knew right away that she was going to be a great fit," said Webb.

Her main duties were to answer the phone, sort mail, assist

Aving a big heart, patience and endless amounts of energy will often times lead you right where you need to be in life, and that's especially true for Lapeer County Community Mental Health's Employee of the Year, Emma Lyons.

And for her, it was CMH's Autism Benefit Services at Maple Grove.

To understand more about what Lyons does on a daily basis, we first wanted to share some facts about autism. The Centers for Disease Control (CDC) says that Autism Spectrum Disorder (ASD) is a developmental disability caused by differences in the brain and affects how that person talks, learns, acts and makes friends. Both kids and adults can have ASD.

Additionally, The CDC is says that early intervention is key to helping kids with ASD because it can reduce the challenges they face and help them learn new skills.

That's where Lyons and her coworkers come in — the entire department is dedicated to teaching and caring for children with autism

spectrum disorders and their families. They do that by putting plans in place both at home and at school to increase the level of understanding when it comes to certain behaviors.

Lyons is an Applied Behavior Analysis (ABA) technician, and she works one-on-one providing ABA services to children with autism, helping to tailor therapy to meet a child's specific needs and to help them work toward various goals.

"We are here to help guide children and their families through rough times, and to celebrate success," said Lyons.

Lyons admits that she jumped up and down when she learned that she was nominated as Employee of the Year.

"I was so thankful and happy. It's a huge honor for me." She has spent the past five years being someone that kids and families can count on and helping them

"Seeing their faces on a daily basis means everything to me," said Lyons.


Being a part of a child's journey in the Autism Department means getting creative

"If I hadn't started coming here, I would probably still be struggling with depression," said Kalar.

Since becoming a Harmony Hall club member, she has experienced a lot of firsts.

One of them was finding a job. Kalar currently works at Metamora

Market, and her job duties include cleaning and taking outdated products off the shelves. "It's a really nice place to work, and I like the people I work with," said Kalar.

Harmony Hall also gave Kalar the chance to go on her first vacation - which was to the Toledo Zoo.

She's also looking forward to going to Mackinac Island this summer, which will be her second vacation.

She also learned how to use a computer for the first time at Harmony Hall too.

"I didn't know much about computers before coming here, but now I know how to edit video," she said.

Kalar said the thing she likes the most about coming to Harmony Hall is the friendly atmosphere.

"I have made a lot of great friends here, and they're like my family, staff included.'

She credits her case manager, Dena Kautz, for introducing her to Harmony Hall family.
